- **Nomination forms** are available from the Returning Officer or the registered offices of the Organisation. The use of these forms is not compulsory provided that nominations comply with the rules.
- **Ballot**: If a ballot is necessary, voting material will be posted on 2 October 2012 to eligible members at the address shown in the Organisation's records. Members should notify the Organisation of any change of address. The ballot will close at 10:00am on 23 October 2012.
